- a) Direct Respondent to admit the claim of the Applicant as per Section 102 of the Insolvency & Bankruptcy Code, 2016 read with rule 8A of the IBBT (Insolvency Resolution process for Corporate Persons) Regulations, 2016;
- b) Direct Respondent to include the Applicants' name in the list of creditors and consequently in the Committee of Creditors with proportional voting rights; or in the alternative;
- c) Direct Respondent to include the details of the Applicant's claim in a revised Information Memorandum to be shared with prospective resolution applicants;

- d) Direct the resolution applicants to accordingly submit a revised resolution plan;
- e) Direct the CoC to consider the addendum or revised resolution plan afresh and approve/reject the same on merits; and

In the light of order passed by this Adjudicating Authority on 23.08.2023 in IA-1161/2022 & batch, the Resolution Professional is directed to consider the claim filed by the Applicants and treat the Applicants at par with other creditors.
